Workforce through Increased Training, Education and Career  
Pathways**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 22 MRSA §3740-A** is enacted to read:

3 **§3740-A. Early childhood educators workforce support program**

4 The commissioner, the Commissioner of Education and the Commissioner of Labor  
5 jointly shall develop and implement an early childhood educators workforce support  
6 program, referred to in this section as "the program," to recruit and retain early childhood  
7 educators working with children up to 5 years of age. Components of the program must  
8 include the following:

9 **1. Career and technical education.** Increasing opportunities for course work in  
10 early childhood education by:

11 A. Expanding the number of career and technical education centers at which early  
12 childhood education programs are available;

13 B. Supporting early childhood education courses through funding for training and the  
14 purchase of updated textbooks, equipment and other course materials; and

15 C. Creating articulation agreements with the Maine Community College System for  
16 the transfer of credits for course work related to early childhood education and  
17 enrollment in courses in furtherance of the issuance of a postsecondary degree;

18 **2. Comprehensive scholarships.** Providing comprehensive scholarships that allow  
19 individuals, such as those providing family child care, directors of child care centers and  
20 early childhood educators, to attain early childhood education credentials and take  
21 courses at accredited institutions leading to associate or bachelor's degrees. The  
22 scholarships must be structured with the goal of allowing an individual who agrees to  
23 work for at least one year following graduation with an approved employer to graduate  
24 without student debt;

25 **3. Apprenticeships.** Expanding the number of apprenticeships available in early  
26 childhood child care. The apprenticeships must be registered with the Department of  
27 Labor and offered in partnership with a professional development network that promotes  
28 and supports professionalism in the early childhood child care and education field and  
29 that is operated by a state institution of higher education and must meet any additional  
30 criteria established by rule adopted pursuant to this section; and

31 **4. Salary supplements.** Establishing a system of salary supplements for providers  
32 of child care and early childhood educators working with children up to 5 years of age.  
33 The system of salary supplements must:

34 A. Be on a graded scale that awards salary supplements to an individual based on the  
35 level of education and experience of the individual;

36 B. Award salary supplements to an individual whose employer is a program or  
37 school that is ranked by the office based on the quality of the program or school; and

1           C. Award salary supplements to an individual who has registered on a statewide  
 2           registry that uses a member's work, education and training histories, along with any  
 3           professional credentials, to assign a level on a scale appropriate to that career.

4           The commissioner, the Commissioner of Education and the Commissioner of Labor  
 5           shall adopt routine technical rules pursuant to Title 5, chapter 375, subchapter 2-A to  
 6           implement the provisions of this section.

7           **Sec. 2. Appropriations and allocations.** The following appropriations and  
 8           allocations are made.

10          **General Purpose Aid for Local Schools 0308**

11          Initiative: Provides ongoing funds to support the expansion of early childhood education  
 12          programs currently offered by 20 career and technical education centers in the State to 27  
 13          career and technical education centers and to update textbooks, equipment and other  
 14          curriculum materials.

4 **SUMMARY**

5 This bill requires the Commissioner of Health and Human Services, the  
6 Commissioner of Education and the Commissioner of Labor jointly to develop and  
7 implement an early childhood educators workforce support program to recruit and retain  
8 early childhood educators working with children up to 5 years of age. Components of the  
9 program include:

10 1. Expansion of educational programs at career and technical education centers and  
11 financial support of those programs;

12 2. Comprehensive scholarships for persons taking classes toward the attainment of  
13 an early childhood education credential or an associate or bachelor's degree that allow the  
14 persons to graduate without student debt as long as the persons agree to work for a year  
15 with an approved employer;

16 3. An increased number of apprenticeships; and

17 4. Salary supplements awarded to individuals who provide child care or who are  
18 early childhood educators. The amount of the supplement is based on the level of  
19 education and experience of the individual and other factors.

20 This bill also provides funding to carry out the program.
