Amend the resolve by striking out all of section 1 and inserting the following:

Department of Health and Human Services to convene a 'Sec. 1. 13 stakeholder group. Resolved: That the Department of Health and Human Services, 14 in consultation with the Department of Education, shall convene a stakeholder group to 15 determine the capacity of the State to respond to its child find responsibilities as required 16 under the federal Individuals with Disabilities Education Act and to provide early and 17 periodic screening, diagnostic and treatment services, referred to in this resolve as 18 19 "screening, diagnostic and treatment services," to children from birth to 8 years of age, the gaps in services and the costs of addressing those gaps. The Department of Health 20 and Human Services shall coordinate the collection and analysis of data from across the 21 department and from organizations that conduct developmental screenings or offer 22 services or treatment to children from birth to 8 years of age, including through Head 23 Start programs, Early Head Start programs, the Child Development Services System as 24 defined in section 7001, public health nursing organizations, the Department of Health 25 and Human Services' home visiting service and the Department of Education. 26 The 27 Department of Health and Human Services shall submit a report with the findings to the Joint Standing Committee on Health and Human Services. The report must include the 28 following: 29

Data on the number, ages and geographic locations of children from birth to 8
years of age receiving screening, diagnostic and treatment services;

32 2. The capacity of the State to ensure that all children from birth to 8 years of age 33 who require screening, diagnostic and treatment services are located and receive services;

34 3. Current levels of federal and state funding designated or available to support child 35 find services, screening, diagnostic and treatment services and early intervention and 36 special education services for children from birth to 8 years of age;

4. Barriers that impede access to child find and screening, diagnostic and treatment services;

5. Data on the disposition of referrals of children from birth to 8 years of age at high risk of developmental delay or disability who are screened and eligible for either child development services or screening, diagnostic and treatment services, including how many receive needed services and how many do not receive those services by county;

6. Shortages of providers of child find and screening, diagnostic and treatment 7 8 services including a breakdown by county of those shortages and a breakdown by specific 9 service:

10 7. An assessment of the State's efforts to provide comprehensive developmental screening for children from birth to 8 years of age with reference to the recommendations of the American Academy of Pediatrics;

8. An assessment of the deficits in the State's efforts to provide comprehensive 13 14 developmental screening;

9. An estimate of the costs to address the shortages in child find and screening, 15 16 diagnostic and treatment services and any recommendations to ensure or expand services 17 so that all children from birth to 8 years of age are adequately served regardless of health 18 insurance status, age, geographic location or type of developmental delay or disability 19 identified:

20 10. A review of existing reports from the past 10 years from organizations that 21 screen for developmental delay or provide services or treatment to children from birth to 22 8 years of age to review existing data, strengths and challenges of programs providing early intervention services; 23

24 11. Additional data needed to assess the State's child find and screening, diagnostic and treatment services; and 25

26 12. Information on other states that have had success in providing child find and 27 screening, diagnostic and treatment services to children from birth to 8 years of age and their families. 28

29 The Department of Health and Human Services shall submit the report no later than 30 December 30, 2019. The Joint Standing Committee on Health and Human Services may 31 report out legislation relating to the subject matter of the report to the Second Regular Session of the 129th Legislature.' 32

33 Amend the resolve by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively. 34
