Resolved: That the Superintendent of Insurance shall determine the compliance of health insurance carriers in this State with the federal Paul Wellstone and Pete Domenici Mental Health Parity and Addiction Equity Act of 2008 and the Maine Revised Statutes, Title 24, sections 2325-A and 2329 and Title 24-A, sections 2749-C, 2842, 2843 and 4234-A. To determine compliance as required by this section, the superintendent may authorize a market conduct examination or use a survey tool to assess compliance.	15 16 17 18 19 20 21 22

The bill requires the Superintendent of Insurance to determine the compliance of health insurance carriers with federal and state mental health parity laws and submit a report. Additional costs to the Bureau of Insurance, within the Department of Professional and Financial Regulation, to carry out these provisions can be absorbed within existing resources.
