To confer and negotiate in good faith with respect to wages, hours, working 18 conditions and contract grievance arbitration, except that by such obligation neither 19 party may be compelled to agree to a proposal or be required to make a concession and except that public employers of teachers shall in accordance with subsection 1-A 20 21 meet and consult but not negotiate with respect to educational policies, except that 22 educational policies related to preparation and planning time and transfer of teachers 23 are permissive subjects of negotiation; for the purpose of this paragraph, educational 24 policies may not include wages, hours, working conditions or contract grievance 25 arbitration; 26 Sec. 2. 26 MRSA §965, sub-§1-A is enacted to read: 27 1-A. Meet and consult. The obligation of public employers of teachers and the 28 bargaining agent to meet and consult under subsection 1, paragraph C is governed by this 29 subsection. 30

A. A public employer of teachers shall give written notice to the bargaining agent

when a change in educational policy is planned by the public employer of teachers. Upon receipt of the written notice, the bargaining agent may initiate the meet and

consult process by notifying the public employer of teachers, including the

superintendent. The public employer of teachers may also initiate the meet and

consult process by notifying the bargaining agent.

#### THE STATE OF THE S COMMITTEE AMENDMENT " To H.P. 1345, L.D. 1879 The public employer of teachers shall, upon receipt of a request from the 1 2 bargaining agent, provide to the bargaining agent information necessary for the bargaining agent and the employees to understand the planned change and make 3 suggestions or express concerns about the planned change. 4 5 C. When notice to initiate the meet and consult process is given under paragraph A, 6 authorized representatives of the public employer of teachers and the bargaining 7 agent shall meet and consult at reasonable times and places about the planned change. The parties shall meet and consult openly, honestly and in good faith, and the public 8 employer of teachers shall consider the employees' suggestions and concerns. 9 D. The authorized representatives of the public employer of teachers shall give full 10 and fair consideration to the employees' suggestions and concerns before the change 11 in educational policy is implemented, and the public employer of teachers shall 12 13 decide in good faith whether employees' suggestions or concerns can be accommodated. 14 15 E. The bargaining agent may initiate the meet and consult process by notifying the public employer of teachers when an existing educational policy of the public 16 employer is changed by practice or if the written notice required under paragraph A is 17 inadvertently omitted.' 18 19 **SUMMARY** 20 Current law provides that public employers of teachers must meet and consult but not 21 negotiate with respect to educational policies. This amendment provides that educational policies related to preparation and planning time and transfer of teachers are permissive 22. subjects of negotiation if both parties agree. 23 24 This amendment also specifies the obligation of public employers of teachers 25 regarding the meet and consult process. It is the intent of the amendment to put in statute 26 the meet and consult process as outlined in Southern Aroostook Teachers Association v. 27 Southern Aroostook Community School Committee, MLRB No. 80-35, 80-40 (April 14, 1982). In addition, the amendment provides that the bargaining agent may initiate the 28

### Fiscal Detail and Notes

This legislation provides that educational policies related to preparation and planning time and transfer of teachers are permissive subjects of negotiation if both a public employer of teachers and the bargaining agent agree. Because the bill allows but does not require local school administrative units (SAU's) to negotiate these educational policies, this legislation is not an unfunded state mandate. Additional costs to those SAU's that choose to include these education policies as part of its collective bargaining negotiations will be funded through the SAU's budgeted resources.
