## SUMMARY

This bill reclassifies the Public Utilities Commission's director of emergency services 5 6 communication to be consistent with other commission directors. The bill also adds 4 positions to the commission: a Utility Analyst to perform utility rate case revenue 7 requirement analysis and other activities; a Utility Analyst to perform communications 8 and customer outreach activities; a Senior Consumer Assistance Specialist to perform 9 administrative work in the receipt, analysis and resolution of consumer complaints; and a 10 Public Service Coordinator II to perform 9-1-1 standards compliance, contract 11 management and other tasks related to the administration of the Emergency Services 12 Communication Bureau. 13
