32 33 **SUMMARY**

This amendment expands the use of funds to support shelter operations at all 30 emergency homeless shelters, not just low-barrier emergency shelters as proposed in the bill. It also allows the Maine State Housing Authority to allocate funds to shelters using the funding formula methodology for shelter operations from its Homeless Solutions Rule.

Fiscal Detail and Notes

This bill includes ongoing General Fund appropriations of \$3,000,000 per year beginning in fiscal year 2020-21 to the Shelter Operating Subsidy program within the Maine State Housing Authority (MSHA) to support operations at emergency homeless shelters across the State.
