11 12	Amend the bill in section 6 in §11108-C by striking out all of subsection 4 (page 2, lines 36 to 38 and page 3, lines 1 to 8 in L.D.) and inserting the following:
13 14 15 16 17 18 19	'4. Supervision of junior hunters 16 years of age. A hunter 16 years of age who obtained a junior hunting license before that person reached 16 years of age may not hunt with that license unless the person is in the presence of and under the effective control of an adult a junior hunter supervisor or the person has successfully completed a hunter safety course acceptable under section 11105 established under section 10108 specific to the method of hunting authorized by the license. The following penalties apply to a violation of this subsection:
20 21	A. A person who violates this subsection commits a civil violation for which a fine of not less than \$100 nor more than \$500 may be adjudged; and
22 23 24	B. A person who violates paragraph A after having been adjudicated as having committed 3 or more civil violations under this Part within the previous 5-year period commits a Class E crime.'
25	Amend the bill by adding after section 7 the following:

28	A. "Adult Junior trapper supervisor" means:
29	(1) The parent or guardian of the junior trapper; or

31	(a) Is approved by the parent or guardian of the junior trapper; and

Sec. 13. 12 MRSA §12204, sub-§2, as amended by PL 2013, c. 538, §34, is further amended to read:

2. Adult <u>Apprentice trapper</u> supervisor required. A holder of an apprentice trapper license may not trap other than in the presence of an adult <u>apprentice trapper</u> supervisor.

Sec. 14. 12 MRSA §12204, sub-§3, as amended by PL 2013, c. 538, §34, is further amended to read:

3. Adult <u>Apprentice trapper</u> supervisor responsibility. An <u>adult apprentice</u> <u>trapper</u> supervisor shall ensure that the holder of an apprentice trapper license follows safe and ethical trapping protocol and adheres to the laws under this Part. An <u>adult apprentice trapper</u> supervisor may not intentionally permit a person trapping under an apprentice trapper license with that <u>adult apprentice trapper</u> supervisor to violate subsection 2.'

SUMMARY

This amendment changes the term that refers to the person who supervises a junior trapper from "adult trapper supervisor" to "junior trapper supervisor." The amendment clarifies that a person 16 years of age who obtained a junior trapping license before that person reached 16 years of age must either successfully complete a trapper education course prior to trapping or be supervised by a junior trapper supervisor while trapping after the person turns 16 years of age.

Additionally, the amendment changes a statutory reference to the hunter safety course a junior hunter is required to complete if not supervised by a junior hunter supervisor.

Any additional costs to the Department of Inland Fisheries and Wildlife as a result of changes to the laws regarding public notice requirements for emergency rulemaking, the definition of a supervisor of a junior or apprentice hunter or trapper and to permits required to possess wildlife in captivity are anticipated to be minor and can be absorbed within existing budgeted resources.
