COMMITTEE AMENDMENT “ ” to H.P. 1411, L.D. 1967, “Resolve, Authorizing the Establishment of Prosecutorial Districts in Downeast Maine”

Amend the resolve by inserting before section 1 the following:

**'Emergency preamble. Whereas,** acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

**Whereas,** this resolve requires the commissioners of Hancock and Washington counties to submit a referendum question to the voters at the statewide election in November 2020; and

**Whereas,** this resolve needs to take effect as soon as possible to provide time for the referendum question to be placed on the ballot; and

**Whereas,** in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it'

Amend the resolve in section 3 in the 4th line (page 1, line 24 in L.D.) by striking out the following: "state and local government" and inserting the following: 'judiciary'

Amend the resolve in section 4 in the 2nd and 3rd lines (page 1, lines 31 and 32 in L.D.) by striking out the following: "state and local government" and inserting the following: 'judiciary'

Amend the resolve by adding after section 5 the following:

**'Sec. 6. Submission permitted. Resolved:** That this resolve is approved only for the purpose of permitting its submission by the county commissioners of Hancock and Washington counties to the legal voters of Hancock and Washington counties at the general election held in November 2020.
