1	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 20-A MRSA §6556 is enacted to read:
3	§6556. Qualification of school security officer
4 5	A school administrative unit as defined in section 1, subsection 26 may employ as a school security officer a person who:
6 7	1. Compliance with criminal history record information requirements. Has complied with the requirements of section 6103; and
8 9	2. Law enforcement officer qualifications. Meets the qualifications for a law enforcement officer either:
10	A. As set forth in Title 25, chapter 341; or
11 12 13	B. By virtue of previously having met the qualifications for and served as a certified law enforcement officer for a state, county, municipal or federal law enforcement agency and having retired from that position in good standing.

27 28 29 30 31 32 33	This bill allows a school administrative unit to employ as a school security officer a person who is a trained law enforcement officer or a person who meets the qualifications for a law enforcement officer as set forth in the Maine Revised Statutes, Title 25, chapter 341 or a person who has retired in good standing from a position as a certified law enforcement officer for a state, county, municipal or federal law enforcement agency and who meets the requirements for criminal history record information of Title 20-A, section 6103.
