An Act To Allow Access to and Ensure the Confidentiality of Records of Child Advocacy Centers

1 Be it enacted by the People of the State of Maine as follows:

Sec. 1. 22 MRSA §4019, sub-§9, as enacted by PL 2013, c. 364, §1, is amended to read:

9. Confidential records. The files, reports, records, communications and working
papers used or developed in providing services under this section are confidential and are
not public records for purposes of Title 1, chapter 13, subchapter 1. Information may be
disclosed only to the following in order for them to carry out their duties:

- 8 A. The department, department employees, law enforcement agencies, prosecuting 9 attorneys, medical professionals and other state agencies that provide services to 10 children and families;
- 11 B. The attorney for a child who is the subject of confidential records; and
- 12 C. A guardian ad litem appointed under section 4005 for a child who is the subject of 13 confidential records-; and

14 D. A court on the court's finding that access to the information may be necessary for the determination of an issue before the court. The court may order the department or 15 a law enforcement agency in possession of such information to provide a copy of the 16 information to the court for in camera inspection. If the court determines that the 17 information is necessary for the resolution of the issue, the court may issue a 18 19 protective order allowing the counsel of record and the clients of the counsel of record to review the information at the court, an office of the department or the law 20 enforcement agency. The court may allow the information to be admitted as 21 evidence under seal. 22

SUMMARY

This bill allows confidential information related to services provided by a child advocacy center to be disclosed to a court if the court finds the information may be necessary for the determination of an issue before the court. If the court determines the information is necessary for the resolution of the issue, the bill authorizes the court to issue a protective order allowing the coursel of record and the clients of the coursel of record to review the information.
