1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 22 MRSA §9053, sub-§7,** as enacted by PL 2015, c. 299, §25, is repealed.

3 **Sec. 2. 22 MRSA §9053, sub-§8,** as enacted by PL 2015, c. 299, §25, is repealed.

4 **Sec. 3. 22 MRSA §9053, sub-§9,** as enacted by PL 2015, c. 299, §25, is repealed.

5 **Sec. 4. 22 MRSA §9053, sub-§18,** as enacted by PL 2015, c. 299, §25, is
6 repealed.

7 **Sec. 5. 22 MRSA §9053, sub-§25,** as enacted by PL 2015, c. 299, §25, is
8 repealed.

25 This bill removes the application of the Maine Background Check Center Act to
26 facilities that provide services for children and to individuals working as direct care
27 workers in such facilities.
