24 **Sec. B-1. PL 2019, c. 415, Pt. C, §1** is amended to read:

25 **Sec. C-1. Carrying provision; Department of Secretary of State,**
26 **Administration - Motor Vehicles program.** Notwithstanding any provision of law
27 to the contrary, the State Controller shall carry forward any unexpended balances in the
28 Personal Services and All Other line categories in the Department of Secretary of State,
29 Administration - Motor Vehicles program, after all financial commitments for salary,
30 benefits and other obligations and budgetary adjustments have been made, at the end of
31 fiscal year 2018-19 to the All Other line category for the 2019-20 fiscal year and at the
32 end of fiscal year 2019-20 to the All Other line category for the 2020-21 fiscal year; in
33 the Department of Secretary of State, Administration - Motor Vehicles program to be
34 used for the procurement and implementation of an automated driver's license testing

1 system for written and road skills tests that must meet conditions prescribed in the
2 Federal Motor Carrier Safety Administration regulations for commercial license
3 examinations hardware and software for computer modernization projects.

4 PART C

5 **Sec. C-1. PL 2019, c. 415, Pt. G, §1** is amended to read:

6 **Sec. G-1. Transfer authorized.** Notwithstanding the Maine Revised Statutes,
7 Title 5, section 1585 or any other provision of law to the contrary, for the fiscal years
8 ending June 30, 2020 and June 30, 2021 the Commissioner of Transportation is
9 authorized to transfer, by financial order upon the recommendation of the State Budget
10 Officer and approval of the Governor, identified Highway Fund Personal Services, All
11 Other or Capital savings in any program in the Department of Transportation to the
12 Department of Transportation, Highway and Bridge Capital, Highway Light Capital and
13 Maintenance and Operations programs for capital or all other needs. The financial order
14 must identify the specific savings after all adjustments that may be required by the State
15 Controller to ensure that all financial commitments have been met in Personal Services
16 after assuming all costs for that program including collective bargaining costs. The
17 Commissioner of Transportation shall provide a report by September 15, 2020 and
18 September 15, 2021 to the joint standing committee of the Legislature having jurisdiction
19 over transportation matters detailing the financial adjustments to the Highway Fund.

20 **Emergency clause.** In view of the emergency cited in the preamble, this
21 legislation takes effect when approved.

23 PART A

24 This Part makes appropriations and allocations.

25 PART B

26 This Part amends a provision in Public Law 2019, chapter 415, Part C to require the
27 State Controller, at the end of fiscal years 2018-19 and 2019-20, to carry forward any
28 unexpended balances in the Personal Services and All Other line categories in the
29 Department of Secretary of State, Administration - Motor Vehicles program, after all
30 financial commitments for salary, benefits and other obligations and budgetary
31 adjustments have been made, to the All Other line category in the Department of
32 Secretary of State, Administration - Motor Vehicles program to be used for the
33 procurement and implementation of hardware and software for computer modernization
34 projects. Public Law 2019, chapter 415, Part C authorized the balances to be used for the
35 procurement and implementation of an automated driver's license testing system.

36 PART C

37 This Part amends a provision in Public Law 2019, chapter 415, Part G to authorize
38 the Commissioner of Transportation, for fiscal years ending June 30, 2020 and June 30,

1 2021, to transfer Highway Fund Personal Services, All Other or Capital savings in any
2 program in the Department of Transportation to the Department of Transportation,
3 Highway and Bridge Capital, Highway Light Capital and Maintenance and Operations
4 programs for capital or all other needs.
