1	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 36 MRSA §5122, sub-§2, ¶UU is enacted to read:
3	UU. For taxable years beginning on or after January 1, 2021, the portion of
4	contributions to a qualified tuition program established under Section 529 of the Code
5	up to \$1,000 per designated beneficiary. This deduction may not be claimed when
6	federal adjusted gross income exceeds \$100,000 for a single individual and married
7	persons filing separate returns or \$200,000 for individuals filing married joint returns
8	and heads of household.
9	SUMMARY
10	This bill reinstates and increases the income tax deduction for contributions to so-called
11	Section 529 education savings plans, providing a deduction up to \$1,000 per designated
12	beneficiary. A deduction up to \$250 was in effect from 2007 to 2015.
