**'Sec. 2. Conditions precedent.** The authorization provided in section 1 may be exercised only if the Director of the Bureau of Parks and Lands within the Department of Agriculture, Conservation and Forestry first gives notice of the proposed conveyance under section 1 and, if a public hearing is requested by any party, the director holds a public hearing on the proposed conveyance as required in the Maine Revised Statutes, Title 12, section 1837, subsection 2.'

**SUMMARY**

This amendment provides that the authorization to convey state land to Maine Veterans' Homes may be exercised only if the Director of the Bureau of Parks and Lands within the Department of Agriculture, Conservation and Forestry first gives notice of the proposed conveyance of state property to Maine Veterans' Homes and, if a public hearing is requested by any party, the director holds a public hearing on the proposed conveyance as required by the Maine Revised Statutes, Title 12, section 1837, subsection 2.

## Fiscal Note

Current biennium revenue increase - Other Special Revenue Funds  
Minor cost increase - General Fund

### Fiscal Detail and Notes

This legislation directs the Department of Agriculture, Conservation and Forestry (ACF) to convey 8.9 acres of Non-Reserved Public Land in Augusta to the Maine Veterans' Homes and would result in an increase in Other Special Revenue Funds revenue to the Nonreserved Land Acquisition Fund. The amount of revenue received will not be known until an appraisal is completed. Any additional cost to complete an appraisal of the conveyance is anticipated to be minor and can be absorbed within existing budgeted sources.
