1	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 20-A MRSA §6355, sub-§4, as enacted by PL 2019, c. 154, §3, is amended
3	to read:
4	4. Student covered by individualized education plan who elected exemption on or
5	before September 1, 2021. A student covered by an individualized education plan on
6	September 1, 2021 who elected a philosophical or religious exemption from immunization
7	requirements on or before September 1, 2021 pursuant to the law in effect prior to that date
8	may continue to attend school under that student's existing exemption as long as:
9	A. The parent or guardian of the student provides a statement from a licensed
10	physician, nurse practitioner or physician assistant that the physician, nurse practitioner
11	or physician assistant has consulted with that parent or guardian and has made that
12	parent or guardian aware of the risks and benefits associated with the choice to
13	immunize; or
14	B. If the student is 18 years of age or older, the student provides a statement from a
15	licensed physician, nurse practitioner or physician assistant that the physician, nurse
16	practitioner or physician assistant has consulted with that student and has made that
17	student aware of the risks and benefits associated with the choice to immunize.
18	SUMMARY
19	Current law allows a student covered by an individualized education plan who elected
20	a philosophical or religious exemption from immunization on or before September 1, 2021
21	to continue to attend school after September 1, 2021 without being immunized as long as
22	certain statements regarding acknowledgement of the risks and benefits associated with the
23	choice to immunize are provided.

This bill extends that exemption to any student who elected a philosophical or religious exemption from immunization on or before September 1, 2021.
