### **SUMMARY**

This amendment, which is the unanimous report of the committee, changes the pilot program to provide that:

- 1. The Commissioner of Education must distribute grant funds across all counties in the State equally among prekindergarten to grade 5, grade 6 to grade 8 and grade 9 to grade
- 2. The commissioner must give priority to applicants that do not currently offer computer science learning opportunities; serve socioeconomically disadvantaged school districts; prioritize student populations traditionally underrepresented in computer science; demonstrate a commitment to pursuing high-quality educator professional development that emphasizes integration of computer science into other course work and curricula or expands or establishes access to courses that offer college credit and other certificates of value, or both; and collaborate or partner with other entities, including but not limited to other local education agencies, the business community, nonprofit organizations and private entities;
- 3. The funds may be used only for high-quality, teacher-developed or teacher-led professional development; and
- 4. Each local education agency that receives a grant under the pilot program must engage in evaluation activities including interviews or surveys on the process and effect and outcomes of the professional development, participate in a community of educators engaged in similar work and annually for the duration of the grant submit to the Department of Education a report or other product that showcases learning and a narrative reflection. The department must compile the submissions and make them available for educators across the State.

The amendment also provides \$250,000 in each year of the biennium to fund the pilot program.

#### Fiscal Detail and Notes

This bill establishes a 2-year pilot program to award grants to local education agencies to provide professional development in computer science instruction. It includes General Fund appropriations of \$250,000 in fiscal year 2021-22 and \$250,000 in fiscal year 2022-23 to a newly created Professional Development Grant Pilot Program account within the Department of Education for this purpose. The bill also includes Federal Expenditures Fund and Other Special Revenue Funds base allocations of \$500 per year for fiscal years 2020-21, 2021-22 and 2022-23 to a newly established Professional Development Grant Pilot Program Fund in order to expend any funds received from federal and outside sources.

Additional costs to the Department of Education to administer the program and to prepare and submit the required report can be absorbed within existing budgeted resources.
