Products used 21 for preserving wood, controlling or treating indoor insects, controlling or treating insects 22 outside around structural foundations and other parts of structures and treating pets, as 23 defined under Title 7, section 712, subsection 16, are specifically exempt from the 24 classification change to restricted use under this section. Rules adopted pursuant to this 25 section are routine technical rules as defined in Title 5, chapter 375, subchapter 2 A. 26 Amend the resolve by relettering or renumbering any nonconsecutive Part letter or 27 section number to read consecutively. 28 SUMMARY 29 This amendment directs the Department of Agriculture, Conservation and Forestry, 30 31 Board of Pesticides Control to change the classification of any product containing certain neonicotinoids used for application in outdoor residential landscapes such as on lawn, turf 32 or ornamental vegetation from general use to restricted use. The amendment adds products 33 used for controlling or treating insects outside around structural foundations and other parts 34
