13	Amend the resolve by inserting after the title the following:
14 15	'Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and
16 17 18	Whereas, this resolve directs the Maine Health Data Organization to determine the best methods and definitions to use in collecting data to assist in analyzing racial and ethnic disparities in health care in this State; and
19 20	Whereas, this resolve requires the Maine Health Data Organization to submit a report to the Legislature by October 1, 2021; and
21 22	Whereas, immediate enactment of this resolve is necessary to provide adequate time for the Maine Health Data Organization to complete the tasks required in this resolve; and
23 24 25 26	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it'
27	Amend the resolve by adding before the summary the following:
28 29	'Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.'

31	This amendment adds an emergency preamble and emergency clause to the resolve.
