7	§3814. Penalties for unlicensed practice
8 9 20 21 22 23	Persons who hold themselves out to the public as psychologists or psychological examiners or engage in psychological practice as defined in this chapter and do not then possess in full force valid licenses to practice as psychological examiners or psychologists under this chapter are subject to the provisions of Title 10, section 8003-C. A person who engages in the practice of a psychological examiner or psychologist without a license under this chapter has engaged in an unfair trade practice in violation of Title 5, chapter 10.

2	8-A. Professional counseling. "Professional counseling" means providing counseling

22	This amendment replaces the bill, which is a concept draft.
23	The amendment clarifies that a person may not engage in the practice of professional
24	counseling or profess to the public to be a, or assume or use the title or designation of,
25 26	clinical professional counselor, professional counselor, marriage and family therapist, licensed pastoral counselor, registered counselor or conditional license holder without
27	holding a valid license or registration in this State.
28	The amendment makes it an unfair trade practice for persons to represent themselves
29	to the public as social workers, psychologists or counseling professionals without a valid
30	license to practice.
31	The amendment adds an effective date of July 1, 2022.
