This bill adds forest rangers and forest fire prevention specialists in the forest protection unit within the Department of Agriculture, Conservation and Forestry, Bureau of Forestry who have contracted cancer to the list of firefighters under the workers' compensation laws whose cancer is presumed to be caused by their firefighting duties.
