## An Act To Allow Deer Baiting by Hunters

1	Be it enacted by the People of the State of Maine as follows:
2 3	<b>Sec. 1. 12 MRSA §10902, sub-§7-C,</b> as amended by PL 2019, c. 630, §2, is further amended to read:
4 5 6	<b>7-C. Hunting deer over bait.</b> A hunting license of a person adjudicated of placing or hunting over bait in violation of section $11452$ $11452$ -A, subsection 1, 2 or 3 must be revoked, and that person is ineligible to obtain a hunting license as follows:
7	A. For a first offense, for a period of one year from the date of adjudication; and
8	B. For a 2nd offense, for a period of 2 years from the date of adjudication.
9	Sec. 2. 12 MRSA §11452, as amended by PL 2019, c. 630, §3, is repealed.
10	Sec. 3. 12 MRSA §11452-A is enacted to read:
11	<u>§11452-A. Deer baiting</u>
12 13	<b>1. Placing of deer bait.</b> During an open season on deer, a person may not place bait to hunt deer unless:
14 15 16	A. The person holds a valid license to hunt deer issued under section 11109 and a permit to place bait to hunt deer issued by the department in accordance with rules adopted by the department;
17 18	B. In addition to the fee required for a license under section 11109, the person pays a fee of \$5 to the department for each bait site established by the person; and
19 20	C. The person complies with the provisions of section 11227, except as otherwise provided in this section.
21 22	<b>2.</b> Hunting over bait. A person may not hunt over bait unless the person complies with the provisions of subsection 1.
23 24	<b>3.</b> Hunting over another's bait. Notwithstanding section 11227, subsection 3, a person may not hunt at a bait site established by another person.
25 26	<b>4. Penalty.</b> A person who violates this section commits a civil violation for which a fine of not less than \$500 nor more than \$1,000 may be adjudged.
27 28 29	<b>5.</b> Rules. The department shall adopt rules to implement this section. Rules adopted pursuant to this subsection are routine technical rules as defined in Title 5, chapter 375, subchapter 2-A.
30 31 32	For the purposes of this section, "bait" has the same meaning as in section 11227, subsection 1, paragraph A and "bait site" has the same meaning as in section 11227, subsection 1, paragraph B.
33	SUMMARY
34	This bill authorizes the baiting of deer by licensed hunters.
