10 Bureau of Parks and Lands To Convey Certain Land in Township 12, Range 13 WELS in  
11 Exchange for Other Land in Township 11, Range 10 WELS"

12 Amend the resolve by striking out the title and substituting the following:

13 **'Resolve, Directing the Bureau of Parks and Lands To Provide Annual Updates on**  
14 **Efforts To Consolidate the Bureau's Unconsolidated Public Lots'**

15 Amend the resolve by striking out everything after the title and inserting the following:

16 **'Sec. 1. Director of Bureau of Parks and Lands directed to report progress**  
17 **on consolidating common and undivided parcels. Resolved:** That, until March 1,  
18 2026, the Director of the Bureau of Parks and Lands within the Department of Agriculture,  
19 Conservation and Forestry shall include in the bureau's annual report on public reserved,  
20 nonreserved public and submerged lands, which is submitted on or before March 1st each  
21 year, a progress report on the bureau's efforts to consolidate common and undivided public  
22 lot parcels that are held in common with private landowners.'

23 Amend the resolve by relettering or renumbering any nonconsecutive Part letter or  
24 section number to read consecutively.

25 SUMMARY

26 This amendment strikes and replaces the resolve. The amendment directs the Director  
27 of the Bureau of Parks and Lands within the Department of Agriculture, Conservation and  
28 Forestry to include in the bureau's annual report on public reserved, nonreserved public and  
29 submerged lands a progress report on the bureau's efforts to consolidate common and  
30 undivided public lot parcels that are held in common with private landowners.
