1 2	Be it enacted by the People of the State of Maine as follows: Sec. 1. 25 MRSA c. 318-A is enacted to read:

3	CHAPTER 318-A
4	EXPIRED MARINE FLARES
5	§2491. Definitions
6 7	As used in this chapter, unless the context otherwise indicates, the following terms have the following meanings.
8 9	<b>1. Commissioner.</b> "Commissioner" means the Commissioner of Public Safety or the commissioner's designee.
10 11	<b>2. Expired.</b> "Expired" means, with regard to a marine flare, beyond the manufacturer- designated period of recommended use.
12 13	<b>3. Fire inspector.</b> "Fire inspector" means a person designated by the commissioner to collect expired marine flares.
14 15	<b>4. Marine flare.</b> "Marine flare" means a device designed to produce a bright flame for use as a signal or marker on the inland or coastal waters of the State or at sea.
16	§2492. Collection program
17 18	The commissioner shall establish and oversee a program for the convenient and safe collection of expired marine flares pursuant to this section.
19 20	<b>1. Site collection.</b> The commissioner shall coordinate the following site collection <u>operations.</u>
21 22 23 24 25 26	A. The commissioner shall, in coordination with a statewide association of fire chiefs, identify fire departments in the State that have the capacity and willingness to accept expired marine flares from members of the public. A participating fire department may choose to designate the geographic area from which the fire department will accept expired marine flares. A participating fire department and the commissioner shall coordinate for timely pickup of the collected expired marine flares.
27 28	B. The commissioner shall coordinate with sponsors of annual community events that choose to include expired marine flare collection as part of their events.
29	C. The commissioner shall coordinate with marinas, municipalities and groups that
30 31	organize events at which the public is invited to drop off expired marine flares for timely collection.
32 33 34	2. Short-term storage. The commissioner shall provide guidance for short-term storage to persons collecting expired marine flares under subsection 1 if the commissioner determines that safety equipment or special procedures are required.
35 36 37 38	<b>3. Direct collection.</b> The commissioner shall designate fire inspectors to collect expired marine flares in a timely way from individuals who fish commercially and recreational boaters in the State who contact the Department of Public Safety to notify the department of expired marine flares in need of disposal.

1	§2493. Disposal program
2	The commissioner shall establish a program for the safe, nonpolluting disposal of all
3	types of expired marine flares pursuant to this section.
4	1. Short-term storage. Expired marine flares collected pursuant to section 2492 that
5	require short-term storage must be stored according to standards established by the
6	Department of Public Safety.
7 8	<b>2.</b> Sorting. Expired marine flares collected pursuant to section 2492 must be sorted by type for proper incineration.
9	3. Incineration. Expired marine flares sorted pursuant to subsection 2 must be
10 11	incinerated at temperatures that are compliant with Department of Environmental Protection standards for preventing air pollution.
12	4. Recycling. To the extent practicable, material from incinerated expired marine
13	flares must be recycled.
14	§2494. Education program
15	The commissioner shall establish an education program for the public and state
16	agencies regarding expired marine flares pursuant to this section.
17	1. Education campaign. The Department of Public Safety shall engage in an
18	education campaign to inform the public and personnel of the Department of Public Safety,
19	the Department of Agriculture, Conservation and Forestry, the Department of Inland
20	Fisheries and Wildlife, the Department of Environmental Protection and the Department of
21	Marine Resources and other potentially interested entities about the expired marine flare
22 23	collection and disposal programs under this chapter, the dangers expired marine flares pose
23 24	to public health and the dangers expired marine flares that are improperly disposed of pose to the environment and to the safety of persons and property.
25	
23 26	<b>2. Department websites.</b> The Department of Public Safety shall maintain a publicly accessible website supporting the education campaign under subsection 1 and serving as
20	an information resource regarding expired marine flares and their proper disposal pursuant
28	to this chapter. The Department of Public Safety, the Department of Agriculture,
29	Conservation and Forestry, the Department of Inland Fisheries and Wildlife, the
30	Department of Environmental Protection and the Department of Marine Resources shall
31	coordinate to update their publications and publicly accessible websites that are suited for
32	the purpose with information regarding the collection and disposal of expired marine flares
33	pursuant to this chapter.
34	3. Printed materials. Materials published by a state agency and intended for those
35	who fish commercially or for recreational boaters must, in printings that occur on or after
36	the effective date of this subsection, include information about environmental and safety
37	concerns related to improper disposal and storage of expired marine flares. The expired
38	marine flare collection and disposal programs established pursuant to this chapter must be
39	described in these print materials, including contact information for the Department of
40	Public Safety's expired marine flare collection and disposal programs.
41	4. State agency notification. The commissioner shall notify other state agencies or
42	entities as the commissioner determines appropriate about the expired marine flare
43	collection and disposal programs under this chapter.

1	Sec. 2. 36 MRSA c. 727 is enacted to read:
2	CHAPTER 727
3	MARINE FLARE DISPOSAL FEE
4	§5011. Marine flare disposal fee imposed
5	A fee is imposed on the retail sale in this State of marine flares in the amount of $25\phi$
6 7	per flare for the purpose of offsetting the cost to the General Fund of paying for the marine flare disposal, education and collection programs pursuant to Title 25, chapter 318-A.
8	1. Marine flare. As used in this chapter, unless the context otherwise indicates,
9 10	<u>"marine flare" means a device designed to produce a bright flame for use as a signal or</u> marker on the inland or coastal waters of this State or at sea.
10	2. Exemption. Transactions that, under the laws of this State, are not subject to
11	taxation in accordance with Part 3 are exempt from the fee imposed by this section.
13	3. Administration. The fee imposed by this section is administered as provided in
14 15	chapter 7 and Part 3, with the fee imposed pursuant to this chapter to be considered as imposed under Part 2. The revenue derived from the fee imposed by this chapter must be
15	imposed under Part 3. The revenue derived from the fee imposed by this chapter must be deposited in the General Fund.
17	4. Effective date. This chapter takes effect January 1, 2022.
18	SUMMARY
19	This bill establishes within the Department of Public Safety programs for the collection
20	and disposal of expired marine flares and for education of the public and state agency
21 22	personnel regarding expired marine flares. It establishes a marine flare disposal fee to offset the costs.
