An Act To Ensure the Timely and Transparent Delivery of Unofficial Election Results in Maine

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 21-A MRSA §700, as amended by PL 2019, c. 320, §6, is repealed and the following enacted in its place:

§700. Posting of unofficial election results

- 1. **Definition.** For the purposes of this section, unless the context otherwise indicates, "unofficial election results" means the number of votes cast in a ward or precinct as declared by the warden pursuant to section 695, subsection 3 in an election other than an election determined by ranked-choice voting with respect to each state or municipal question that appeared on a ballot in that ward or precinct and for each candidate, including each declared write-in candidate pursuant to section 722-A, for a federal, state, county or municipal office that appeared on the ballot in that ward or precinct. For an election determined by ranked-choice voting, "unofficial election results" means the results of the first choice votes cast for each candidate, including each declared write-in candidate pursuant to section 722-A.
- **2. Posting of unofficial election results.** As soon as practicable after declaring the results pursuant to section 695, subsection 3, the warden shall:
 - A. Post a paper copy of the unofficial election results at the voting place or at the municipal office in a secure place where the public may view that copy of the unofficial election results even when the voting place or municipal office is closed; and
 - B. Electronically transmit the unofficial election results to the Secretary of State in a format approved by the Secretary of State.
 - **3. Secretary of State duties.** The Secretary of State shall:
 - A. Immediately post unofficial election results received pursuant to subsection 2, paragraph B on the Secretary of State's publicly accessible website;
 - B. Upon receipt of an attested copy of an election return pursuant to section 711, subsection 3, correct any errors in the unofficial election results posted on the Secretary of State's publicly accessible website pursuant to paragraph A; and
 - C. Develop and implement a statewide public awareness program about the availability of unofficial election results under this section.
- 4. Acceptance of funds. The Secretary of State may accept gifts, donations and grants from any private or public source, in addition to money appropriated or allocated by the State, for the purposes of implementing this section.

33 SUMMARY

This bill requires, as soon as practicable after the election results are tabulated, the posting of unofficial election results for each municipality outside either the municipal office or each voting place in the municipality as well as on the Secretary of State's publicly accessible website.
