1 **Emergency preamble.** Whereas, acts and resolves of the Legislature do not 2 become effective until 90 days after adjournment unless enacted as emergencies; and 3 Whereas, the spread of the novel coronavirus disease referred to as COVID-19 has 4 created a public health emergency; and 5 Whereas, public schools in the State have experienced significant declines in student enrollment resulting from the COVID-19 pandemic, and consequently, school funding 6 needs to be addressed as soon as possible; and 7 8 Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as 9 immediately necessary for the preservation of the public peace, health and safety; now, 10 11 therefore, 12 Be it enacted by the People of the State of Maine as follows: Sec. 1. 20-A MRSA §15674, sub-§1, ¶C, as amended by PL 2017, c. 284, Pt. C, 13 §29, is further amended to read: 14 15 C. Beginning in fiscal year 2018-19 2021-22: 16 (1) The average of the pupil counts for October 1st of the 2 most recent calendar years prior to the year of funding, reported in accordance with section 6004, 17 including the counts of students enrolled in an alternative education program made 18 19 in accordance with section 5104-A, except that if a school administrative unit experiences a decline in total school administrative unit student enrollment of 10% 20 21 or more in a single year, the pupil count used for operating costs in this Act for that school administrative unit is the average of the pupil counts for October 1st of the 22 23 3 most recent calendar years prior to the year of funding, reported in accordance 24 with section 6004, including the counts of students enrolled in an alternative 25 education program made in accordance with section 5104-A. 26 **Emergency clause.** In view of the emergency cited in the preamble, this legislation 27 takes effect when approved. 28 SUMMARY 29 This bill requires the Department of Education to use a 3-year average for pupil counts 30 when a school administrative unit experiences a decrease of 10% or more of total school 31 administrative unit student enrollment in a single year.
