24-hour shelters for persons experiencing homelessness. New construction and expansion projects funded by the program must address an increase in the need for shelter capacity in the region since the construction, or expansion, of an existing shelter or shelters in the region or since the start of the outbreak of COVID-19 or both. The bill includes a one-time General Fund appropriation of \$3,000,000 in fiscal year 2021-22 to the Maine State Housing Authority to fund the program. This bill specifies that the funding is supplemental to funding for the Maine State Housing Authority's emergency shelter and housing assistance program.
