Fiscal Detail and Notes

The bill includes General Fund deappropriations to the Department of Health and Human Services of \$361,128 in fiscal year 2021-22 and \$375,843 in fiscal year 2022-23 for the repeal of coverage to MaineCare members for legal abortion services.
