.3	This amendment does the following.
.4 .5	1. It clarifies that a surcharge imposed by a state department or agency includes a service fee.
6 7 8	It adds a cross-reference to clarify that a state department or agency must disclose a surcharge prior to payment and that a surcharge may not exceed the costs associated with providing the credit card or debit card service.
9 0	3. It clarifies that the definition of "governmental entity" includes a plantation organized pursuant to the Maine Revised Statutes, Title 30-A.

Fiscal Detail and Notes

This bill allows a state department or agency to impose a surcharge for payments made by credit card or debit card. Any state department or agency that accepts debit or credit card payments will now be able to recoup associated fees and charges instead of absorbing them, resulting in savings to the department or agency. In fiscal year 2019-20, cre card charges across all funds and all of state government totaled \$1.1 million.
