Fiscal Detail and Notes

This amendment changes the General Fund appropriations to the Department of Health and Human Services from \$628,551 to \$239,821 in fiscal year 2022-23 due to an adjustment to federal match for the new payments. This amendment also increases the Federal Expenditures Fund allocation.
