The changes in the bill are expected to increase the number of complaints to the Maine Human Rights Commission. The bill includes General Fund appropriations of \$121,034 in fiscal year 2021-22 and \$119,124 in fiscal year 2022-23 for one part-time Maine Human Rights Investigator position, one part-time attorney and related All Other costs.
