17 18	'Notwithstanding any other provision of this section, the Passamaquoddy Tribe's jurisdiction does not extend beyond the Passamaquoddy Indian territory.'
19 20 21 22 23	Amend the amendment in section 12 in paragraph F in the last line (page 4, line 14 in amendment) by inserting after the following: " <u>10</u> " the following: ', except that the Passamaquoddy Tribe may not exercise jurisdiction over a nonprofit public municipa corporation, including, but not limited to, the water district established by Private and Special Law 1983, chapter 25'

27 28 29 30 31	This amendment provides that the Passamaquoddy Tribe's jurisdiction with respect to drinking water does not extend beyond the Passamaquoddy Indian territory. It also provide that, with respect to the Passamaquoddy Tribe's jurisdiction over civil and criminal action regarding the enforcement of ordinances enacted by the Passamaquoddy Tribe regulating drinking water within the Passamaquoddy Indian territory, the Passamaquoddy Tribe may
