Fiscal Detail and Notes

This bill includes a General Fund appropriation of \$84,179 in fiscal year 2022-23 to the Regulation and Enforcement program within the Department of Labor for one Labor and Safety Inspector position and related All Other costs associated with enforcement of the law regarding nondisclosure agreements pursuant to Title 26, section 599-C. This fiscal note assumes an August 1, 2022 effective date.

Additional General Fund revenue from the assessment of fines is expected to be minor.
