l	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 20-A MRSA §13011, sub-§6-C is enacted to read:
3	6-C. Additional pathway for industrial arts certification. The state board shall
4	adopt rules relating to the credentialing of educational personnel to create a pathway for a
5	teacher to obtain a conditional certificate and a pathway for a teacher to obtain an
6	endorsement on a teaching certificate for a component of industrial arts as defined by the
7	department with an experiential lab that includes, but is not limited to, automotive body
8	repair, diagnostics and mechanics; welding; electrical; carpentry; and computer-aided
9	design. This endorsement must be separate from other endorsements.
10	A. At a minimum, rules adopted pursuant to this subsection to obtain a conditional
11	certificate must include the following qualifications:
12	(1) A completed apprenticeship registered with a statewide or national
13	apprenticeship and training organization;
14	(2) A completed 2-year degree or certificate from a technical institution accredited
15	by a national association of career and technical schools or similar organization;
16	<u>and</u>
17	(3) Completion of a minimum of 36 months of paid work experience or teaching
18	experience in a career and technical endorsement area, of which a minimum of 12
19	months was:
20	(a) At a supervisory level; and
21	(b) Completed during the 5 years immediately preceding application for a
22	conditional certificate or endorsement under this subsection.
23	Rules adopted pursuant to this subsection are major substantive rules as defined in Title 5,
24	chapter 375, subchapter 2-A.
25	SUMMARY
26	This bill directs the State Board of Education to adopt rules to amend the credentialing
27	of educational personnel to create a pathway for a teacher to obtain a conditional certificate
28	and a pathway for a teacher to obtain an endorsement on a teaching certificate for a
29	component of industrial arts with an experiential lab.
