An Act To Allow a Customer with a Net Energy Billing Arrangement To Annually Donate Any Unused Kilowatt-hour Credits

- 2 Sec. 1. 35-A MRSA §3209-A, sub-§5 is enacted to read:
- 5. Donation of unused kilowatt-hour credits. Not more than once per year, a
 customer that has a net energy billing arrangement with a transmission and distribution
 utility may donate any unused kilowatt-hour credits accumulated by that customer to
 another customer of that same transmission and distribution utility.

7 Sec. 2. Public Utilities Commission review of net energy billing shared 8 interest. The Public Utilities Commission shall review the Maine Revised Statutes, Title 9 35-A, section 3209-A and the Public Utilities Commission rule Chapter 313, Customer Net Energy Billing, to determine if it is unreasonably burdensome for a small number of 10 residential customers of a transmission and distribution utility to create a shared financial 11 interest in a distributed generation resource for the purposes of net energy billing. In 12 conducting the review, the commission shall also evaluate whether applicable provisions 13 are clearly written and easily understandable. By December 1, 2021, the commission shall 14 submit the results of the review conducted pursuant to this section to the Joint Standing 15 Committee on Energy, Utilities and Technology and shall include any suggested legislation 16 or rule changes resulting from the review. The committee may report out a bill based on 17 the report to the Second Regular Session of the 130th Legislature. 18

SUMMARY

This bill allows, not more than once per year, a customer that has a net energy billing arrangement with a transmission and distribution utility to donate any unused kilowatt-hour credits accumulated by that customer to another customer of that same transmission and distribution utility.

24 It also requires the Public Utilities Commission to review the Maine Revised Statutes, 25 Title 35-A, section 3209-A and its rule Chapter 313, Customer Net Energy Billing, to 26 determine if it is unreasonably burdensome for a small number of residential customers of a transmission and distribution utility to create a shared financial interest in a distributed 27 generation resource for the purposes of net energy billing and to evaluate whether the rules 28 29 regarding shared financial interest among a small number of residential customers only are clearly written and easy to understand. It requires the commission to report back to the 30 31 Joint Standing Committee on Energy, Utilities and Technology by December 1, 2021 the 32 results of its review and to include any suggested legislation or rule changes. It allows the committee to report out a bill based on the report to the Second Regular Session of the 33 34 130th Legislature.
