1 Be it enacted by the People of the State of Maine as follows: 2 Sec. 1. 21-A MRSA §610 is enacted to read: 3 §610. Election transparency 4 1. Transparency of election procedures. The Secretary of State shall produce and publicly disseminate a guide to election procedures and revise the guide annually to reflect 5 current law, rules and procedures regarding elections. The guide must describe: 6 7 A. Rules regarding polling places and the conduct of elections; 8 B. Devices and software used to capture, interpret or tally votes and the capabilities and deployment of the devices and software; 9 10 C. Duties of election officials on, before and after election day: 11 D. Opportunities for citizens to monitor election procedures; and 12 E. Other election laws, rules or procedures that the Secretary of State determines appropriate for the public interest. 13 14 2. Election complaints. The Secretary of State shall develop an election complaint 15 process that any election official or member of the public can use to report excessive wait times, noncompliance with election procedures, obstacles or interference with voting or 16 other concerns about the election process. Instructions for filing a complaint under this 17 subsection must be included in the guide to election procedures under subsection 1 and 18 posted at all polling places. The Secretary of State shall keep a record of the complaints 19 20 received under this subsection and any actions taken in response to the complaints. 2.1 **3. Election report.** By December 15th in a year following a general election year, the 22 Secretary of State shall submit a report to the Legislature that includes for all elections 23 since the prior general election: 24 A. A summary of the election complaints received under subsection 2; 25 B. The number of voters removed from the central voter registration system since the 26 previous report and the reason for their removal; 27 C. A summary of any recounts conducted, including a description of any discrepancies in vote totals and explanations for discrepancies when available; and 28 29 D. Recommendations for the remedy of any problems identified in the election process 30 at the state or local level. 31 4. Rules. The Secretary of State may adopt routine technical rules as defined in Title 5, chapter 375, subchapter 2-A to carry out the purposes of this section. 32 33 Sec. 2. Resolve 2019, c. 48 is repealed. 34 Deadline for producing and disseminating guide to election 35 **procedures.** The Secretary of State shall produce and disseminate a guide to election procedures pursuant to the Maine Revised Statutes, Title 21-A, section 610, subsection 1 36 37 no later than December 1, 2021. 38 Sec. 4. Secretary of State to conduct pilot post-election audit. The Secretary 39 of State shall design and conduct a pilot post-election audit based on statistical principles

designed to limit the risk that certified election returns may produce an incorrect outcome.

The pilot audit must be conducted following the general election scheduled for November 2022. The planning process for the pilot audit must include a study of best practices in post-election ballot audits, recounts and the intersection of audits with recounts and must include a review of security protocols related to hardware, software and paper ballots. In conducting the pilot audit, the Secretary of State may consult with state and municipal election officials, election security advocates and other experts in the field of election audits and recounts. By February 1, 2023, the Secretary of State shall submit a report on the pilot audit with any recommended legislation to the joint standing committee of the Legislature having jurisdiction over veterans and legal affairs. The joint standing committee may report out a bill based upon the report to the First Regular Session of the 131st Legislature.
