## An Act To Establish a License Plate in Support of Multiple Sclerosis Programs

1	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 29-A MRSA §456-I is enacted to read:
3	§456-I. Support multiple sclerosis programs registration plates
4 5	Notwithstanding section 468, the Secretary of State shall issue support multiple sclerosis programs special registration plates in accordance with this section.
6 7 8 9 10 11	<b>1.</b> Support multiple sclerosis programs registration plates. The Secretary of State, upon receiving an application and evidence of payment of the excise tax required by Title 36, section 1482, the annual motor vehicle registration fee required by section 501 or 504 and the contribution provided for in subsection 3, shall issue a registration certificate and a set of support multiple sclerosis programs special registration plates to be used in lieu of regular registration plates.
12 13 14 15 16 17 18 19	2. Design; review; vanity plates. The Secretary of State, in consultation with the plate sponsor, shall determine a design for the support multiple sclerosis programs special registration plates. The joint standing committee of the Legislature having jurisdiction over transportation matters shall review the final design prior to manufacture of the plates. The Secretary of State shall issue upon request support multiple sclerosis programs special registration plates that are also vanity plates. Support multiple sclerosis programs special registration plates are issued in accordance with the provisions of this section and section 453.
20 21 22 23	3. Contribution; credit to funds. In addition to the regular motor vehicle registration fee prescribed by law for the particular class of vehicle registered, the initial contribution for support multiple sclerosis programs special registration plates is \$20, which must be deposited with the Treasurer of State and credited as follows:
24 25	A. Ten dollars to the regional chapter of a nationwide multiple sclerosis society to support multiple sclerosis programs;
26 27	B. Nine dollars to the Highway Fund for administrative and production costs; and C. One dollar to the Specialty License Plate Fund established under section 469.
28 29 30 31	<b>4. Renewal fee.</b> In addition to the regular motor vehicle registration fee prescribed by law, the annual renewal contribution for support multiple sclerosis programs special registration plates is \$15, which must be deposited with the Treasurer of State and credited as follows:
32 33	A. Ten dollars to the regional chapter of a nationwide multiple sclerosis society to support multiple sclerosis programs;
34 35	<ul> <li>B. Four dollars to the Highway Fund for administrative and production costs; and</li> <li>C. One dollar to the Specialty License Plate Fund established under section 469.</li> </ul>
36 37 38 39 40 41 42	5. Payment for costs associated with the production and issuance of the first 2,000 plates. The sponsor of the support multiple sclerosis programs special registration plates shall provide \$50,000 to the Secretary of State for costs associated with the production and issuance of support multiple sclerosis programs special registration plates. The Secretary of State shall deposit these funds in the Specialty License Plate Fund established under section 469. In accordance with section 468, subsection 3-A, the Secretary of State shall provide 2,000 credit receipts to the sponsor.

1 6. Transfer of fees. On a quarterly basis, the Secretary of State shall transfer the revenue from the issuance and renewal of support multiple sclerosis programs special 2 registration plates to the Treasurer of State for deposit and crediting pursuant to subsections 3 4 3 and 4. 5 7. Duplicate plates prohibited. The Secretary of State shall issue a support multiple sclerosis programs special registration plate in a unique 3-number and 3-letter combination 6 sequence. Vanity plates may not duplicate vanity plates issued in another class of plate. 7 8 8. Date of first issue. The Secretary of State shall issue the first support multiple sclerosis programs special registration plate by October 1, 2023. 9 10 SUMMARY 11 This bill creates the support multiple sclerosis programs special registration plate to 12 support multiple sclerosis programs.
