Resolved: That the Department of Health and Human 14 Services shall draft the plan in collaboration with other agencies of the executive branch, 15 indigenous and tribal populations of the State, the Permanent Commission on the Status of 16 Racial, Indigenous and Maine Tribal Populations, consumer groups, service providers, 17 public safety organizations, law enforcement organizations, hospitals, the LGBTQ 18 community and any other interested parties and seek public input. For purposes of this 19 resolve, "LGBTQ" includes but is not limited to lesbian, gay, bisexual, transgender, queer, 20 questioning, intersex and asexual.' 21 Amend the resolve in section 3 in the first line (page 1, line 18 in L.D.) by striking out 22 the following: "department" and inserting the following: 'Department of Health and Human 23 24 Amend the resolve in section 4 in the first line (page 2, line 24 in L.D.) by striking out 25 the following: "department" and inserting the following: 'Department of Health and Human 26 27 Amend the resolve by relettering or renumbering any nonconsecutive Part letter or 28 section number to read consecutively. 29

SUMMARY

The resolve requires the Department of Health and Human Services to develop a comprehensive statewide strategic plan to serve people with behavioral health needs throughout their life span. The amendment removes references to individual offices within the Department of Health and Human Services for the drafting of the plan. It also removes
