1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 7 MRSA §3911**, as amended by PL 1999, c. 254, §3, is further amended to
3 read:

4 **§3911. Dogs at large**

5 It is unlawful for any dog, licensed or unlicensed, to be at large, ~~except when used for~~
6 ~~hunting~~. The owner or keeper of any dog found at large is subject to the penalties provided
7 in this chapter.

8 **Sec. 2. 12 MRSA §10902, sub-§7**, as affected by PL 2003, c. 614, §9 and amended
9 by c. 655, Pt. B, §100 and affected by §422, is further amended to read:

10 **7. Mandatory hunting license revocation; coyote hunting violation.** A hunting
11 license of a person convicted of hunting coyote in violation of section ~~11206~~ 11206; section
12 11227, subsection 8; or ~~12001~~ section 11228, subsection 4 must be revoked and that person
13 is ineligible to obtain any hunting license for a period of one year from the date of
14 conviction.

15 **Sec. 3. 12 MRSA §11160**, as corrected by RR 2011, c. 1, §17, is repealed.

16 **Sec. 4. 12 MRSA §11227, sub-§8** is enacted to read:

17 **8. Prohibition.** A person may not hunt coyote by the use or placement of bait. A
18 person who violates this section commits a civil violation for which a fine of not less than
19 \$100 or more than \$500 may be adjudged.

20 **Sec. 5. 12 MRSA §11228**, as enacted by PL 2011, c. 432, §2, is amended to read:

21 **§11228. Hunting with dogs**

22 **1. Collar required.** A person may not hunt with a dog in pursuit of bear, ~~coyote~~ or
23 bobcat unless the dog has a collar that legibly provides the name, telephone number and
24 address of the owner of that dog.

25 A. A person who violates this subsection commits a civil violation for which a fine of
26 not less than \$100 or more than \$500 may be adjudged.

27 B. A person who violates this subsection after having been adjudicated as having
28 committed 3 or more civil violations under this Part within the previous 5-year period
29 commits a Class E crime.

30 **2. Limit on number of dogs.** A person or persons may not use more than 6 dogs at
31 any one time to hunt ~~coyotes~~ or bobcats. A person who violates this subsection commits a
32 Class E crime.

33 ~~**3. Night hunting with dogs.** A person may not use a dog to hunt coyotes during the~~
34 ~~period from 30 minutes after sunset to 30 minutes before sunrise. A person who violates~~
35 ~~this subsection commits a Class E crime.~~

36 **4. Prohibition.** A person may not hunt with a dog in pursuit of coyote. A person who
37 violates this subsection commits a civil violation for which a fine of not less than \$100 or
38 more than \$500 may be adjudged.

39 **Sec. 6. 12 MRSA c. 915, sub-c. 12**, as amended, is repealed.

This bill amends the hunting laws by:

1. Removing the hunting exception from the prohibition of allowing dogs at large;
2. Repeals provisions allowing coyote hunting at night and hunting with dogs;
3. Provides for hunting license revocation for the hunting of coyotes at night, with dogs or by the use or placement of bait; and
4. Prohibits the hunting of coyotes by the use or placement of bait or with dogs.
