## An Act To Restrict the Sale, Purchase and Use of Fireworks in the State

1	Be it enacted by the People of the State of Maine as follows:
2 3	Sec. 1. 8 MRSA §221-A, sub-§1-A, as enacted by PL 2011, c. 416, §1 and affected by §9, is repealed.
4 5	Sec. 2. 8 MRSA §221-A, sub-§3-A, as enacted by PL 2011, c. 416, §2 and affected by §9, is repealed.
6 7	<b>Sec. 3. 8 MRSA §221-A, sub-§4,</b> as amended by PL 2011, c. 416, §3 and affected by §9, is further amended by amending the first blocked paragraph to read:
8 9 10 11 12 13 14	The term "fireworks" does not include consumer fireworks or toy pistols, toy canes, toy guns or other devices in which paper caps or plastic caps containing 25/100 grains or less of explosive compound are used if they are constructed so that the hand can not come in contact with the cap when in place for the explosion, toy pistol paper caps or plastic caps that contain less than 20/100 grains of explosive mixture, sparklers that do not contain magnesium chlorates or perchlorates or signal, antique or replica cannons if no projectile is fired.

17 18 19	1. Sale of fireworks prohibited. Except for the sale of consumer fireworks under section 223-A, a $\underline{A}$ person may not sell, possess with the intent to sell or offer for sale fireworks.

21 22	<b>Sec. 6. 8 MRSA §236,</b> as repealed and replaced by PL 2011, c. 416, §6 and affected by §9, is repealed and the following enacted in its place:

24 25 26 27	The commissioner shall adopt reasonable rules relative to the use, storage, transportation and display of fireworks and special effect pyrotechnics. Rules adopted pursuant to this section are routine technical rules pursuant to Title 5, chapter 375, subchapter 2-A.

Ordinances.</b> Chapter 141, but only with respect to animal control ordinances, subject to Title 7, section 3950, the sale and use of consumer fireworks within the plantation, subject to Title 8, section 223-A, and the accumulation of garbage, refuse, rubbish or trash or unwanted or discarded material of any kind or source on private property.
