1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 22 MRSA §2353, sub-§3**, as amended by PL 2017, c. 220, §1, is further  
3 amended to read:

4 **3. Authorized administration of naloxone hydrochloride by law enforcement**  
5 **officers, corrections officers, emergency medical services persons, ambulance**  
6 **services, nontransporting emergency medical services and municipal firefighters.** A  
7 law enforcement agency as defined in Title 25, section 3701, subsection 1, a regional or  
8 county jail, a correctional facility as defined in Title 34-A, section 1001, subsection 6, an  
9 emergency medical services provider under Title 32, chapter 2-B, an ambulance service as  
10 defined in Title 32, section 83, subsection 5, a nontransporting emergency medical service  
11 as defined in Title 32, section 83, subsection 14 or a municipal fire department as defined  
12 in Title 30-A, section 3151, subsection 1 is authorized to obtain a supply of naloxone  
13 hydrochloride to be administered in accordance with this subsection. A law enforcement  
14 officer as defined in Title 17-A, section 2, subsection 17, in accordance with policies  
15 adopted by the law enforcement agency, a corrections officer who possesses a current and  
16 valid certificate issued by the Board of Trustees of the Maine Criminal Justice Academy  
17 pursuant to Title 25, section 2803-A, in accordance with policies adopted by the jail or  
18 correctional facility, an emergency medical services person as defined in Title 32, section  
19 83, subsection 12 who possesses a current and valid license issued by the Medical Direction  
20 and Practices Board pursuant to Title 32, section 85, in accordance with policies adopted  
21 by the emergency medical services provider, an ambulance service as defined in Title 32,  
22 section 83, subsection 5 that possesses a current and valid license issued by the Medical  
23 Direction and Practices Board pursuant to Title 32, section 86, in accordance with policies  
24 adopted by the ambulance service, a nontransporting emergency medical service as defined  
25 in Title 32, section 83, subsection 14 that possesses a current and valid license issued by  
26 the Medical Direction and Practices Board pursuant to Title 32, section 86, in accordance  
27 with policies adopted by the nontransporting emergency medical service, and a municipal  
28 firefighter as defined in Title 30-A, section 3151, subsection 2, in accordance with policies  
29 adopted by the municipality, may administer intranasal naloxone hydrochloride as  
30 clinically indicated if the officer, emergency medical services person, ambulance service,  
31 nontransporting emergency medical service or firefighter has received medical training in  
32 accordance with protocols adopted by the Medical Direction and Practices Board  
33 established in Title 32, section 83, subsection 16-B. The Medical Direction and Practices  
34 Board shall establish medical training protocols for law enforcement officers, corrections  
35 officers, emergency medical services persons, ambulance services, nontransporting  
36 emergency medical services and municipal firefighters pursuant to this subsection.

37 **SUMMARY**

38 This bill authorizes emergency medical services persons, ambulance services and  
39 nontransporting emergency medical services to administer intranasal naloxone  
40 hydrochloride if they have received medical training in accordance with protocols adopted  
41 by the Medical Direction and Practices Board.
