13 14 15 16 17 18 19 20	'Sec. 58. State to discontinue use of terms "handicap," "handicapped" and "hearing impaired". Departments, agencies and offices of the legislative, executive and judicial branches of State Government shall discontinue the use of the terms "handicap," "handicapped" and "hearing impaired" to describe a person or set of persons in all laws, rules and official documents. The commissioner's office of each department of State Government shall report to the Joint Standing Committee on Judiciary by December 1, 2021 regarding progress on removing the terms from official documents and a reasonable time frame to complete the removal.'
21 22	Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

24 25 26 27 28	The bill requires the Department of Labor to monitor the progress of updating terminology in official documents across State Government. This amendment requires the commissioner's office of each department of State Government to report to the Joint Standing Committee on Judiciary by December 1, 2021 regarding progress on the update and to provide a reasonable time frame for completion of the update.
