The joint standing committee of 35 the Legislature having jurisdiction over energy and utility matters may report out 36 legislation related to the program to the 131st Legislature.' 37

HOUSE AMENDMENT

#### SUMMARY

This amendment requires the Public Utilities Commission to perform an additional competitive solicitation for 150 megawatts of energy by December 31, 2024, limited to a project located on previously developed or contaminated land.

It requires the Efficiency Maine Trust to submit a bid or bids for at least 50% of the megawatts solicited under the procurement conducted by the commission under the Maine Revised Statutes, Title 35-A, section 3210-G, subsection 1, paragraph B-2.

It changes the date by which the Efficiency Maine Trust has to submit a report to February 15, 2023, adds an additional requirement regarding value to ratepayers to that report and allows the report to recommend the repeal of the program.
