An Act To Provide Services to Maine's Most Vulnerable Citizens by Eliminating the Waiting Lists for Certain MaineCare Services

(EMERGENCY)

Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, persons with disabilities have the right to dignity and to receive the support they need to work and to be otherwise included in their communities; and

Whereas, many persons with disabilities have an urgent need for adult home and community-based services to provide support and to enable their family members to work; and

Whereas, as of December 2019, more than 180 persons on the MaineCare Section 21 waiver waiting lists were receiving no services at all; and

Whereas, providing services for more MaineCare members eligible for Section 29 services ensures dignity and safety; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine as follows:

Sec. 1. Appropriations and allocations. The following appropriations and allocations are made.
