The analysis must include the current demographic and geographic representation on these boards, how other states make appointments to policy-making educational boards and recommendations on how to ensure demographic and geographic representation across the State on policy-making educational boards in this State. The Department of Education shall submit a report with its findings and recommendations, no later than January 15, 2022, to the Joint Standing Committee on Education and Cultural Affairs. The Joint Standing Committee on Education and Cultural Affairs may submit a bill related to the report to the Second Regular Session of the 130th Legislature.
