1	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 30-A MRSA §4726 is enacted to read:
3	§4726. Rental registry for multifamily housing
4 5 6 7 8	The Maine State Housing Authority shall create a commission to develop a comprehensive rental registry, referred to in this section as "the registry" for multifamily housing in the State. The commission must consist of representatives of large and small municipalities, multifamily housing owners and renters and other interested parties invited to participate by the Maine State Housing Authority. The commission shall:
9 10 11 12	<b>1. Information.</b> Design the registry to include information that the commission determines relevant, including data on ownership, management, occupancy status, condition, code violations, lead abatement and inspection history of all multifamily housing in the State;
13	2. Available to public. Make the registry available on a publicly accessible website;
14 15 16	<b>3. Outreach.</b> Investigate models and best practices for outreach to rental property owners and managers and for data collection, formatting, display, consolidation and updating of data;
17 18	<b>4.</b> Common platform. Identify or create and implement a common platform for data collection, formatting and display;
19 20	<b>5. Data consistency.</b> Establish an ongoing process for maintaining data consistency and quality; and
21 22	6. Disseminate information. Disseminate information on the registry, including processes and systems, to interested municipalities.
23 24 25 26 27	<b>Sec. 2. Report.</b> By February 1, 2022, the commission shall submit a report on the progress of the comprehensive rental registry of multifamily housing to the Maine State Housing Authority. On or before January 1, 2023 and annually thereafter, the Maine State Housing Authority shall report on the progress of the registry to the joint standing committee of the Legislature having jurisdiction over labor and housing matters.

29 30 31 32 33 34	This bill directs the Maine State Housing Authority to create a commission to develop, implement and disseminate to municipalities and post on a publicly accessible website a comprehensive rental registry of multifamily housing in the State. The commission consists of representatives of large and small municipalities, owners and renters of multifamily housing and other interested parties invited by the authority. The authority is directed to report annually to the Legislature on the progress of the registry.
