**An Act Directing the Maine State Housing Authority To Create a  
Commission To Develop a Comprehensive Rental Registry for  
Multifamily Housing**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 30-A MRSA §4726** is enacted to read:

3 **§4726. Rental registry for multifamily housing**

4 The Maine State Housing Authority shall create a commission to develop a  
5 comprehensive rental registry, referred to in this section as "the registry" for multifamily  
6 housing in the State. The commission must consist of representatives of large and small  
7 municipalities, multifamily housing owners and renters and other interested parties invited  
8 to participate by the Maine State Housing Authority. The commission shall:

9 **1. Information.** Design the registry to include information that the commission  
10 determines relevant, including data on ownership, management, occupancy status,  
11 condition, code violations, lead abatement and inspection history of all multifamily housing  
12 in the State;

13 **2. Available to public.** Make the registry available on a publicly accessible website;

14 **3. Outreach.** Investigate models and best practices for outreach to rental property  
15 owners and managers and for data collection, formatting, display, consolidation and  
16 updating of data;

17 **4. Common platform.** Identify or create and implement a common platform for data  
18 collection, formatting and display;

19 **5. Data consistency.** Establish an ongoing process for maintaining data consistency  
20 and quality; and

21 **6. Disseminate information.** Disseminate information on the registry, including  
22 processes and systems, to interested municipalities.

23 **Sec. 2. Report.** By February 1, 2022, the commission shall submit a report on the  
24 progress of the comprehensive rental registry of multifamily housing to the Maine State  
25 Housing Authority. On or before January 1, 2023 and annually thereafter, the Maine State  
26 Housing Authority shall report on the progress of the registry to the joint standing  
27 committee of the Legislature having jurisdiction over labor and housing matters.

28 **SUMMARY**

29 This bill directs the Maine State Housing Authority to create a commission to develop,  
30 implement and disseminate to municipalities and post on a publicly accessible website a  
31 comprehensive rental registry of multifamily housing in the State. The commission consists  
32 of representatives of large and small municipalities, owners and renters of multifamily  
33 housing and other interested parties invited by the authority. The authority is directed to  
34 report annually to the Legislature on the progress of the registry.
