This amendment replaces the bill. It requires that the core training provided to guardians ad litem must include no less than 6 hours on domestic abuse and violence. The amendment requires that continuing education for guardians ad litem must include at least 2 hours of training annually on the impact of domestic abuse and violence on children, the services available in Maine for victims of domestic abuse and violence and their children and interventions for those who commit domestic abuse and violence. The amendment contains an effective date of January 1, 2022.
