### Fiscal Detail and Notes

The bill includes General Fund appropriations to the Department of Health and Human Services of \$713,564 in fiscal year 2022-23 for the new claims associated with the change to allow the provision of personal support services by a relative chosen by the recipient of services in a home setting including one-time funding for technology changes. Federal Expenditures Fund and Other Special Revenue Funds allocations are also included for the FMAP match.
