12	'Sec. 1. 24-A MRSA §601, sub-§33 is enacted to read:
13 14	33. Self-storage insurance provider. Self-storage insurance provider fees may not exceed:
15	A. Issuance of license for self-storage insurance provider, \$100; and
16	B. Annual renewal fee, \$50.
17 18 19	Amend the bill in section 4 in c. 97 in §7501 in subsection 4 in the first line (page 1, line 29 in L.D.) by inserting after the following: "physical location" the following: 'of a self-storage facility'
20 21 22	Amend the bill in section 4 in c. 97 in §7504 in subsection 1 in paragraph C in the last line (page 3, line 34 in L.D.) by striking out the following: "nonlimited" and inserting the following: 'limited'
23 24	Amend the bill in section 4 in c. 97 in §7506 in subsection 5 in the last line (page 5, line 4 in L.D.) by striking out the following: "29" and inserting the following: '33'
25 26	Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
27	SUMMARY
28	This amendment makes the following changes to the bill.
29 30	1. It adds a section establishing the maximum fee at \$100 for self-storage insurance provider initial license fees and at \$50 for annual renewal fees.
31 32	2. It clarifies the definition of "location" to reflect that locations include the site of the self-storage facilities.

- 3. It revises language in the bill to clarify that a self-storage provider may not hold itself out as having anything but a limited lines license in order to sell or offer self-storage insurance.
