**An Act To Help Veterans Who Are Caregivers of Children with
Special Needs and of Family Members To Optimize Their Respite
Hours**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 37-B MRSA §508-A** is enacted to read:

3 **§508-A. Veteran caregivers**

4 The bureau shall ensure that veteran service officers have the training and resources
5 necessary to:

6 **1. Caregivers of children with special needs.** Provide information to veterans who
7 are caregivers of children with special needs on state and federal resources and programs
8 for respite hours and services and on any available funding for respite hours and services;
9 and

10 **2. Caregivers of family members.** Provide information to veterans and assistance to
11 veterans who provide caregiver services to their family members who are not veterans on
12 utilizing federal caregiver programs.

13 **Sec. 2. Review of federal caregiver programs for veterans.** The Director of
14 the Maine Bureau of Veterans' Services within the Department of Defense, Veterans and
15 Emergency Management shall review which federal caregiver programs exist to assist
16 veterans and report to the Joint Standing Committee on Veterans and Legal Affairs by
17 January 1, 2022 on the potential for and cost of implementing similar programs in the State.
18 The Joint Standing Committee on Veterans and Legal Affairs may report out legislation
19 based upon the report to the Second Regular Session of the 130th Legislature.

20 **Sec. 3. Adapt programs to assist veterans caring for children with special**
21 **needs.** The Director of the Maine Bureau of Veterans' Services within the Department of
22 Defense, Veterans and Emergency Management shall review programs currently provided
23 by the State to veterans and adapt the programs as necessary to ensure the programs provide
24 assistance specifically targeted to the needs of veterans who are caregivers of children with
25 special needs. In adapting programs under this section, the bureau shall ensure that
26 program staff consult with doctors, therapists, educational professionals and other
27 professionals in fields relevant to caring for children with special needs to ensure that the
28 services provided to each veteran who is a caregiver of a child with special needs are
29 adapted to serve the specific needs of that child.

30 **Sec. 4. Other services for veterans caring for children with special needs.**
31 The Director of the Maine Bureau of Veterans' Services within the Department of Defense,
32 Veterans and Emergency Management shall consult with and provide resources to other
33 entities in the State that offer services to veterans to encourage those entities to provide
34 services specifically targeted to the needs of veterans who are caregivers of children with
35 special needs.

36 **SUMMARY**

37 This bill directs the Department of Defense, Veterans and Emergency Management,
38 Maine Bureau of Veterans' Services to ensure that veteran service officers are able to
39 provide information to veterans who are caregivers of children with special needs on state
40 and federal resources and programs and any available funding for respite hours and services
41 and provide information and assistance to veterans in utilizing federal caregiver programs
42 for family members who are not veterans. It directs the Director of the Maine Bureau of

1 Veterans' Services to review which federal caregiver programs exist to assist veterans and
2 report back to the Joint Standing Committee on Veterans and Legal Affairs by January 1,
3 2022 on the potential for and cost of implementing similar programs in the State.

4 This bill also directs the director to review programs currently provided by the State to
5 veterans and adapt the programs as necessary to ensure the programs provide assistance
6 specifically targeted to the needs of veterans who are caregivers of children with special
7 needs and to consult with and provide resources to other entities in the State that offer
8 services to veterans to encourage those entities to provide services specifically targeted to
9 the needs of veterans who are caregivers of children with special needs.
